Furthermore, the policy is aimed at eliminating hazards and avoiding risks, acting adequately in case of disasters and preventing material and environmental damage.

CSi is committed to providing a healthy and safe working environment, consistent with own standards, customers' demands, laws and regulations. While carrying out this policy the importance of context of the organization and her stakeholders is taken into consideration. We will strive to eliminate all foreseeable hazards and ensure that occupational diseases, fire and damage to possessions are prevented. In order to reach this aim, CSi industries will implement and maintain an occupational health & safety management system, which complies with the requirements of ISO 45001:2018. CSi packaging industry works according to regulations of ISO 45001,

This policy is being carried out by means of good management, information and education, combined with an active commitment of all employees. Our work is Planned, managed and monitored, we collaborate with subcontractors and principal contractors to assure that the works are carried out without risks to health and safety.

The implementation of the policy will take place under direct responsibility of the Board, supported also by specifically designated persons, management and employees. The Board will ensure that consultation and participation of the employees is made possible within CSi and takes place regularly. A continuous improvement of performance in working conditions, health, safety and environment, and seizing opportunities, will be sought.
